5. Abuse of Centre staff members or spectators.
6. Foul language.
7. Drug abuse
8. Drunken behaviour

**First Offence:** The offender will be given an official warning by their Inter-District Secretary.

**Second Offence:** The penalty for a second offence is possible suspension from the Inter-District Tournament or penalties as described within the Inter-District Tournament Rules (refer Chapter 5 – General Conduct and Chapter 17 - Violations).

### **COMPLAINTS**

Every bowler will have the right to appeal their case before the Inter-District Committee. Any bowler wishing to make a complaint or appeal must do so in writing within 24hours of the alleged event to their Division Secretary.
